

Dumpster/POD-type Storage Container Requirements

For a Dumpster/POD to be placed on the street:

- A permit must be submitted to the Permitting Office three (3) working days in advance of placement.
- Do not order or schedule the delivery of a dumpster/POD prior to City approval.
- Approval of the dumpster or POD on the street is not guaranteed because there are many safety factors involved.
- The request must include a site plan showing the placement of the dumpster/POD and traffic cones needed to ensure safety. See illustration below.
- The dumpster or POD must be parked against the curb and not obstruct driveways, stop signs or fire hydrants, or be placed closer than 20 feet to street corners.
- Only reflective cones (28"-36") shall be used as traffic control devices
- At a minimum, there shall be 4 devices positioned behind the dumpster or POD and 2 (two) on the other end.

DUMPSTER, CONSTRUCTION MATERIALS AND EQUIPMENT PLACEMENT PERMIT IF ON CITY RIGHT-OF-WAY

Sec. 17-34. It shall be unlawful for any person to place or maintain a dumpster, pod-type storage container, construction materials and equipment, landscape materials and equipment, or portable toilet on the public streets, sidewalks or other public right-of-way within the city limits, unless the City Manager or his designee makes a finding that the placement of any of the items set forth in this section on private property would be impractical due to the topography or other physical condition of the land and to set conditions as to the use and placement of such items on public streets, sidewalks or other rights-of-way, in which case any such item may be located on the public street, sidewalk or other public right-of-way with the city limits, as designated in such finding; provided, however, in the event of such finding by the City Manager or his designee, no such item set forth in this section, with the exception of portable toilets, shall remain on the public street, sidewalk or other public right-of-way for more than three (3) days in any continuous thirty (30) day period.

Sec. 17-35. Any person using or in possession of a refuse receptacle (garbage can or dumpster), pod type storage container or portable toilet shall maintain such refuse receptacle, pod type storage container or portable toilet free of graffiti.
