- All Other Signs: Drawings, to scale, for all other signs which include color, lettering, materials and lighting.
- Material samples, (if applicable).
- Written consent of the owner of the real property, or the owner's agent, granting permission for placement of the sign.
- Signed agreement by the applicant to maintain the sign in safe condition.
- Proof that all required permits for the construction sign have been obtained, including but not limited to:
 - GDOT, if located on a State Highway and in the Right of Way.

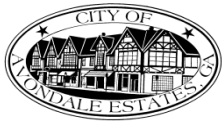


City of Avondale Estates Sign Permit Fees

No permit shall be issued until the appropriate application has been filed with the code enforcement officer and the fees have been paid to the clerk of the court as provided below:

Area of Sign	Cost
Under 2 Square Feet	No Charge
2-10 Square Feet	\$30.00
11-25 Square Feet	\$50.00
26-50 Square Feet	\$75.00
51 Square Feet or Greater	\$100.00
